IMPURITIES:

DIRECTIONS FOR USE:

A phosphate fertiliser. Mainly used for side or top-dressing pasture and forage crops, grain, vegetables and pre-plant application in grain crops. Also used in tree and vine crops. If surface-applied without incorporation, best results are achieved if applied before rain or irrigation. Because climatic and soil conditions, application methods, irrigation, agricultural and grazing management practices are beyond the control of Wengfu Australia Pty Ltd and cannot be foreseen, Wengfu Australia Pty Ltd accepts no responsibility whatsoever for any commercial damage, loss or other result following the use of this product whether used with directions or not, subject to any overriding statutory provision and provided such liability under those provisions shall be limited to the replacement of the goods as supplied or rendering again the services that are provided.
